PLEASE TAKE NOTICE THAT, on November 18, 2021 at 10:00 a.m., in the Courtroom of the Honorable Nelson S. Román, United States District Court, Southern District of New York, Plaintiffs will and hereby do move the Court for an order approving and awarding attorneys' fees, litigation costs, and service awards. By this motion, Plaintiffs seek:

1. \$2,166,666 in attorneys' fees;
2. \$22,903.98 in litigation costs; and
3. Service awards of \$3,000 for each of the named Class Representative Plaintiffs (a total of \$6,000).

This motion is made on the grounds that: (1) such fees are fair and reasonable in light of the efforts of Plaintiffs' counsel in obtaining the settlement herein; (2) the requested attorneys' fees comport with the applicable law; (3) the expenses for which reimbursement is sought were reasonably and necessarily incurred in connection with the prosecution of this action; and (4) a reasonable payment to plaintiffs for their efforts on behalf of the Class is warranted and appropriate. This motion is based upon this Notice of Motion, the accompanying Memorandum of Points and Authorities, the accompanying declarations of counsel in support of Plaintiffs' Motion for Final Approval of Settlement and Motion for Attorneys' Fees, Litigation Costs, and Service Awards, the Declaration of Gina Intrepido-Bowden Regarding Notice Plan and Settlement Administration, the pleadings and records on file herein, and upon such additional evidence or argument as may be accepted by the Court at or prior to the hearing.
